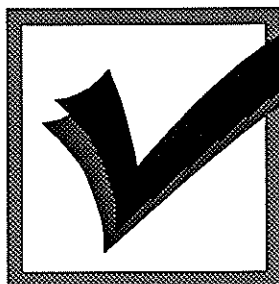

The Crystal Club is a non-profit support group for TV,

TS, TG, FI, and others who assume a complete trans-gendered identity. Spouses and significant others are welcome and are encouraged to participate. Both Male-to-Female and Female-to-Male are welcome. Also, members from related organizations, helping professionals, and approved guests are welcome when cleared through a Crystal Club elected officer.

Meetings are the fourth Saturday evening of each month unless a special event is scheduled that takes the place of the regular scheduled meeting. The location of the meeting or event(s) are only released to members or others with the approval of an officer.

New prospective members must be screened by the Member Representative or another delegated representative of the Crystal

Club. We do not discriminate on the basis of sexual orientation, race, creed, or age of the members and attendees. We do, however, require that all attendees behave like ladies or gentlemen at all times. We are not a dating service or a therapy group. We require that all attendees come completely dressed as a Male or a Female. An adjacent changing room should be available at the meeting site.

The Crystal Club membership fee is \$15 for a individual and \$20 for a couple (member and a significant other/spouse). The start of a new membership is pro-rated in coordination with the Crystal Club fiscal year end of 30 June, in quarter increments (4 months) to the nearest \$5, in advance. Additional consecutive years consist of the standard membership fee, in advance. Meeting fees are: \$15 for a single

member, \$20 for a member couple and \$20 for a single non-member, \$25 for a non-member couple.

We will exchange newsletters with any other similar group. Feel free to include a disk version in ASCII format if possible either on 5.25 or 3.5 floppy. Send all correspondence to:

On the other hand, TV Guide has been running a promotion spot where they parody the talk shows. The commercial features a group of men who are compelled to dress as clowns and the women that love them. They are on the stage of a Geraldo-type show. An accountant says something like, "I did it as a joke at the company picnic and it was wonderful... all my life I've been suppressing the clown inside me that's been struggling to get out!"

I think this could easily be seen as a little "jab" at crossdressers. My female side was slightly offended at first, but my male ego thought it was kinda cute. At least they didn't come right out use men in drag. The added twist of changing it to clowns was creative and brings up an interesting analogy. Secretary's Report

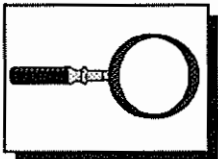
Business Meeting - January 16, 1992

Members present: Rochelle, Eden, Marilyn, Adrienne, and Jennifer G.

First issue that was discussed was ballots for the election in February. It was decided to mail ballots to all members and to vote, they will either have to bring them to the meeting or else return them by mail, post-marked no later than 2/20/92.

Second issue which was discussed was club finances. Expenses are not currently being covered, membership dues do not even cover the cost of preparing the newsletter for a year. Several different options were proposed regarding changing membership fees; from increasing to \$20 per year; \$75 per year, which would also cover meeting fees; \$50 per year with a smaller meeting fee. There was not enough information to adequately appraise all the alternatives, it was moved by Rochelle to raise the fees to \$20 per year effective with March 1992. This proposal passed 3-1. We also decided that this is not a closed issue, and at the February business meeting it is hoped that some specific alternative proposals will be presented.

A discussion was also held to obtain ideas on how we might be able to better assist the newsletter editor in preparing the news letter. Suggestions were made to reduce the size, publish bi-monthly, create an "editorial board" or have an assistant position. Nothing definite was decided, it was felt that we needed direct input from the editor herself to properly address

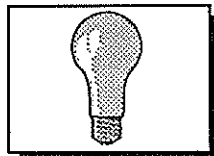

When People Find Out

Dear Cynthia,

I am married to a male who cross-dresses. I knew about his crossdressing before we were married; this is the second marriage for both of us. I really don't have a problem with the crossdressing, as I love my husband regardless of what he wears. I suppose that's because of all the so-called "macho" males I have known, and the one I was married to, it is a treat to find a person that is kind and sensitive, and one I can relate to.

We do have a problem that has puzzled us for a long time. Who can we confide in about this lifestyle we live? I am so tired of making excuses to my friends and family about why they can't come over without plenty of notice. I'm tired of having to make sure the neighbors aren't around when we leave the house while my husband is "dressed." My husband says he is used to it and this is the way it is when you have an unusual lifestyle. But I really don't like having a "secret" life like this. Do you have any suggestions? What do other crossdressers and their families do about this? --P.F.

Dear P.F,

Unfortunately, people do find out, and you really never know how they will react to this. I can give you a few generalities. Women accept it better than men. (Unless, of course, it's your mother, who will probably think he is a monster!)

Friends and relatives can be roughly divided into two groups - ones who handle it badly, get very upset and (hopefully) never have anything further to do with you; and friends and relatives who will be (initially) very curious, and ask a lot of questions, some of which you'll wish they hadn't! But out of this second group can come some of your best friends and supporters.

It is probably a good idea to keep any employer from finding out.

Neighbors? Well, if you live in a typical neighborhood as most of us do, it is going to be difficult to keep it a secret. Some neighbors are just curious and really think they need to know everything about your life. Some really couldn't care less. The best tact to take is to be careful, and try not to rub people's noses in it. But remember: in the long run, you have to run your life as you see fit.

Children present a special problem. Some people tell kids and some would rather die than tell them (and a lot DO die without ever having done so). If a child feels he is part of the family and

the family "secrets" are his to keep to himself, there is no problem. On the other hand, some children can't be told anything. They will immediately run to the nearest person and tell everything they know. This, of course, is a separate problem which needs to be taken care of - because, sooner or later the kids will find out, one way or the other. Better to make it your way.

One thing I have discovered is that if you (the wife or S.O.) don't seemingly have a problem with this, friends, relatives, etc. won't. You will find that you set the mood for someone accepting or not. If you take a lighthearted "no big deal" attitude, others will accept your lead. You certainly do not want to appear as the "put upon" part of the relationship.

Making excuses and acting apologetic towards part of your life with your mate is not the way to make understanding easier. My approach has always been, "Yes, my husband is a crossdresser.... wouldn't it be interesting to know what unusual lifestyles other people lead?"

The final answer to all this: In the long run it isn't anybody else's business how you lead your life, as long as it doesn't hurt anyone else.

Olympic Gender Test may be History

(CBS News) Gender testing is not new to the Olympics, however, it has now become a controversy in Alverville 1992.

Somehow at the winter olympic games where they can distinguish winners and losers by hundredths of a second, they've had trouble telling the boy's from the girls.

When suspicions arose in the sixties that some Eastern European male athletes were competing as women, the Olympics began using a controversial genetic sex test, where a sampling of mouth tissue is examined to see if it contains the XX chromosomes that were thought to distinguish women from the XY chromosomes of men.

The problem is the test is flawed

because a small percentage of women, like former hurdler, Maria Patino, have Y or male chromosomes.

Today the International Armature Athletic Federation, which controls track & field, formerly called for the Chromosome testing to be ended, saying what would seem obvious is that the sex of an athlete can better be determined by a basic physical examination.

"I think sex testing should be abolished. I think it served no useful function and has a bad consequence.", says Dr. Jean Wilson of the University of Texas Southwestern Medical Center.

The olympic movement though, despite the speed of it's participants, has been slow to follow the lead of those calling


for an end to chromosome testing.

The I.O.C. said that it will continue to test here and will do the same at the games in Barcelona this summer.

But gender testing has become a hot issue here. Women athletes complaining not only that the testing was demeaning, but that all it ever really found was women who had chromosome abnormalities because of a genetic accident.

By weighing into the argument today, the powerful athletic federation may well make it impossible for the olympics to continue it's policy of genetic testing. And the outdated process of determining sex under a microscope may soon be over.

NOW group gives go-ahead to form new political party

Fed up with republicans? Disgusted with Democrats? A new political party may be hatched by the National Organization for Women in time for the 1992 presidential election.

A commission that has been working for two years to decide whether NOW should form an independent political party has recommended: Go for it.

The party has no name and no candidates. Forming the party must be approved at NOW's national convention in June. A platform has to be written, and friends have to be brought into the fold.

NOW doesn't expect to pull this off alone. It's officials see a natural alliance

with consumer advocates, health-care providers, environmentalists, gays and lesbians, and supporters of women's rights, civil rights and peace.

None of those people are getting what they want from Democrats or Republicans, said Patricia Ireland, a Miami lawyer and NOW's executive vice president.

"It's the politics of exclusion. Congress is 95 percent white, 95 percent men; it's got two 'out' gay men and no acknowledged lesbians. It's not a representative body," she said.

The new party grew out of NOW's 1989 convention in Cincinnati where hundreds of women rose to their feet chanting "third party, third party." They were still furious about the Supreme Court's Webster decision three weeks earlier allowing states to place further restrictions on abortion.

The new party, they said, was to be

dedicated to a "bill of rights" for the 21st century, which went far beyond abortion rights.

Enthusiasm was harder to find outside NOW.

"The prospects of a third party are slim to none," said David Bositis, a scholar on political parties at the Joint Center for Political Studies.

"There's no woman candidate whom the National Organization for Women is going to nominate who is going to even run remotely as well as John Anderson did in 1980."

NOW, he said, is plagued with "pathetic" leadership and has lost ground on its favorite issue: abortion rights and equal rights for women. He said he believes every special interest has already found a home either with Democrats or Republicans anyway.

Dolly Parton impersonator beaten into a coma

(NATIONAL ENQUIRER) A nationally known male Dolly Parton impersonator was viciously attacked and beaten into a coma - and police suspect a crazed fan of the real Dolly.

The assault on Jimmy Hayes, 34, occurred in the early morning hours of December 29 in West Lounge, a gay night club in Kettering, Ohio, where Hayes works as a waiter and performs as Dolly.

His bloodied and unconscious body was found in a back room by a club worker and an ambulance rushed Hayes to Kettering Medical center, where he was in an intensive care unit.

"The person who did this beat Jimmy so badly, you couldn't tell who he was," said club co-owner Mary Buck. "His head was split open from ear to ear."

Just hours before the attack, Hayes was serving drinks to a packed house and showing customers a picture of him as Dolly and posing with the singer.

After the club closed at 5 a.m., Hayes was in a back room when someone entered through an unlocked rear door and attacked him, according to police.

Said Mary Buck: "It's strange that after he shows the picture he's almost killed. It must have been a fan of Dolly angry over the attention Jimmy was getting."

Detective Les George, who's in charge of the case, confirmed: "We're

investigating that as a reason."

Although Hayes emerged from the coma after several days, he still lapses in and out of consciousness.

Hayes has been impersonating Dolly since the 1970's. He's even appeared in concerts with her.

In 1982 he won a national Dolly look-alike contest.

Buck is organizing a fund-raiser to help Hayes and noted: "Jimmy is a good person. we're praying for him."
